#### **AMENDMENT**

NOW, THEREFORE, the Declaration is amended to add the following Section (to be known as Section 5.25 (Leasing):

(5.25) <u>Leasing.</u> All leases must be in writing and shall be for a term of no less than sixty (60) days. No Owner may lease less than his/her entire Lot or Residential Unit. An Owner shall notify the Association of any lease and shall provide the Association with the tenant information as allowed by A.R.S. 33-1806.01, as may be amended from time to time. The Owner shall be liable for any violation of the Declaration or any Association Rules promulgated thereunder by the tenant(s) or any other persons residing in the Residence.
